## **Road Hazard Tire & Wheel Protection**

Prepare for bumps in the road



## About the plan

Road Hazard Tire & Wheel Protection Plan repairs, or if unrepairable, replaces tires damaged by Road Hazards such as debris on the road surface, potholes, cracks, and breaks.

If tires or wheels are damaged by a Road Hazard, the plan provides for the replacement of wheels only when or if the wheel cannot be balanced, will not hold air, or the damage has affected the structural integrity of the wheel.

### Coverage does not include

Cosmetic damage, such as scratches and dings, and structural damage to tires and wheels caused by collisions with curbs and abnormal wear and tear are not covered. Tire disposal charges or environmental fees are not covered.

Any tire and/or wheel failure caused by accidents, theft, vandalism, misuse, or negligence is also not covered.

### Coverage Limits

- ▶ **Standard Plan:** Up to \$200 for each tire and wheel replacement; \$40 per repair limit. \$1,200 lifetime maximum for the duration of the contract.
- ▶ **Deluxe Plan:** No per occurrence limit for each tire and wheel; \$40 per repair limit. \$5,000 lifetime maximum for the duration of the contract.

### Optional Towing / Roadside Assistance

If this option is selected, in addition to the benefits provided under the Road Hazard Tire & Wheel Protection Plan, you will receive up to \$50 per occurrence for towing and/or roadside assistance expenses incurred in connection with a covered tire and/or wheel.

### Additional Information

This information is intended to provide only an outline of the types of coverages, exclusions, and limitations of the Road Hazard Tire & Wheel Contract just described and should not be relied upon when purchasing this contract. For exact coverages, exclusions, and limitations, please review the contract itself.

The plan is optional and expires according to the contract term selected or when the lowest tread depth reaches 2/32<sup>nds</sup> of an inch, whichever occurs first.

Coverage is limited to the original set of tires on the vehicle at the time of purchase and new replacement tires.

This contract is transferable to another owner but not to another vehicle.

**The purchase of the plan is optional, cancelable, and not required to obtain financing.**
