Announces Regular Cash Distribution for September 2007

Edmonton, Alberta (September 17, 2007) AutoCanada Income Fund (“AutoCanada”) (TSX:ACQ.UN) announced today its regular cash distribution of \$0.0833 per trust unit for the month of September (equivalent to \$1.00 per trust unit on an annualized basis). This distribution will be paid on October 15, 2007 to unitholders of record at the close of business of September 28, 2007.

The policy of AutoCanada is to pay cash distributions on or about the 15th of each month to the unitholders of record on the last business day of the preceding month.

About AutoCanada

AutoCanada is Canada’s only publicly traded entity with interests exclusively in the operation of franchised automobile dealerships. Through its 54% interest in AutoCanada LP, it operates or manages 19 franchised automobile dealerships in six provinces and has over 940 employees. It currently sells various new vehicle brands, including Chrysler, Dodge, Jeep®, Hyundai, Mitsubishi, Subaru, and, through a managed dealership, Nissan. In 2006, its franchised automobile dealerships sold approximately 19,350 vehicles and processed approximately 215,000 service and collision repair orders in 245 service bays, generating revenue of approximately \$694 million.
