How?	All financial companies need to share customers' personal information to run their everyday business. Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. Our affiliates include entities owned or controlled by Ernest A. Boch, Jr., such as The Boch Family Foundation dba Music Drives Us.		
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. Boch Exotics does not share with nonaffiliates so they can market to you.		
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. • Boch Exotics does not jointly market.
