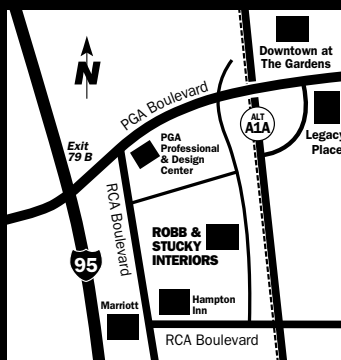
OUR MISSION
