# CONSENT REPECTING PERSONAL INFORMATION

This following terms form part of this Application Statement.

#### A. CREDIT REVIEW

You agree to the dealer and Ford Credit Canada Limited (Ford Credit) / Ford Credit Canada Leasing\* (FCCL) (including third parties acting for them or on their behalf, the "Dealer", "Ford Credit" and "FCCL", respectively), obtaining a credit report or other credit information from any credit reporting agency, credit bureau, or credit grantor (which may require disclosure of certain information in this Application), and exchanging, holding and using such information in order to evaluate your credit and document the decision on your application, including for related audit, quality assurance (including call monitoring) and risk management purposes.
