<b>FACTS</b>	<b>WHAT DOES CHAPMAN FORD MAZDA LINCOLN MERCURY SALES DO WITH YOUR PERSONAL INFORMATION?</b>

<b>Why?</b>	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

<b>What?</b>	<p>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</p> <ul style="list-style-type: none"> <li>■ Social Security number and employment information</li> <li>■ account balances and payment history</li> <li>■ credit history and credit scores</li> </ul>

<b>How?</b>	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Chapman Ford Mazda Lincoln Mercury Sales chooses to share; and whether you can limit this sharing.

<b>Who is providing this notice?</b>	Chapman Ford Mazda Lincoln Mercury Sales

What we do	
<b>How does Chapman Ford Mazda Lincoln Mercury Sales protect my personal information?</b>	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
<b>How does Chapman Ford Mazda Lincoln Mercury Sales collect my personal information?</b>	<p>We collect your personal information, for example, when you</p> <ul style="list-style-type: none"> <li>■ Apply for financing or apply for a lease</li> <li>■ Give us your contact information or provide account information</li> <li>■ Show your government-issued ID</li> </ul> <p>We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.</p>
<b>Why can't I limit all sharing?</b>	<p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"> <li>■ sharing for affiliates' everyday business purposes—information about your creditworthiness</li> <li>■ affiliates from using your information to market to you</li> <li>■ sharing for nonaffiliates to market to you</li> </ul> <p>State laws and individual companies may give you additional rights to limit sharing.</p>
<b>What happens when I limit sharing for an account I hold jointly with someone else?</b>	Your choices will apply to everyone on your account – unless you tell us otherwise.

Definitions	
<b>Affiliates</b>	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> <li>■ <i>Our affiliates include other companies with Chapman Ford Mazda Lincoln Mercury Sales such as Chapman Chevrolet, LLC., Chapman Ford Chrysler Dodge Jeep Ram of Horsham, Chapman Ford of Lancaster, Chapman Ford Sales, Inc, Chapman Ford, LLC, Chapman Management Corporation, and Chapman Nissan, LLC.</i></li> </ul>
<b>Nonaffiliates</b>	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <ul style="list-style-type: none"> <li>■ <i>Nonaffiliates we share with can include direct marketing companies.</i></li> </ul>
<b>Joint Marketing</b>	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <ul style="list-style-type: none"> <li>■ <i>Chapman Ford Mazda Lincoln Mercury Sales doesn't jointly market.</i></li> </ul>
