When it comes time to select a mobility equipment installer, look for one that's a member of the National Mobility Equipment Dealers Association (NMEDA), and ask if they are Quality Assurance Program (QAP)-certified. QAP is a nationally recognized accreditation program for mobility equipment installers. And keep in mind that your Chevrolet dealer is your best source for information about mobility aids.

The full-size Express Van offers **abundant interior space, cargo capacity and accessibility**, making it an excellent choice for installing adaptive equipment, such as a wheelchair lift, ramps and driver aids, all available from independent aftermarket suppliers.² What's more, Express gives you a choice of Regular Wheelbase (at 135 inches) and Extended Wheelbase (at 155 inches) models – longer than available Ford E-Series passenger vans. Inside, Express delivers a host of features, including available **rear air conditioning** and an **auxiliary heater** to help maintain a comfortable environment regardless of outdoor temperatures. **Solar-Ray deep-tinted glass** in the rear side windows and rear door windows is also available and helps moderate temperatures inside. 1. STABILITRAK ELECTRONIC STABILITY CONTROL SYSTEM.

This feature, standard on Express Passenger and Cargo Van models, improves vehicle stability, particularly on slick surfaces or during emergency maneuvers. Also standard are four-wheel ABS and Dynamic Rear Proportioning.

2. HEAD-CURTAIN SIDE-IMPACT AIR BAGS.
