

Rollin' With Dolan

OFFICIAL RULES

1. **Sponsor:** Rollin' With Dolan (the "Contest") is sponsored by Dolan Auto Group, 2100 Kietzke Ln, Reno, NV (the "Sponsor"). The Sponsor is responsible for all aspects of the Contest.
