## WHAT DOES UPSTATE AUTO CREDIT DO WITH YOUR PERSONAL INFORMATION?

### Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

### What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security Number and Income
- Credit History and Credit Scores
- Payment History and Credit Card or Other Debt

### How?

All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Upstate Auto Credit chooses to share; and whether you can limit this sharing.

**Who is providing this notice?**

Upstate Auto Credit means the following institutions: Upstate Auto Credit, Inc. legal entities that utilize the following names: Upstate Auto Credit of Rochester DBA Dorschel Auto Exchange and Upstate Auto Credit of Henrietta.

**What we do**

**How does Upstate Auto Credit protect my personal information?**

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

**How does Upstate Auto Credit collect my personal information?**

We collect your personal information, for example, when you

- Apply for financing
- Give us your contact information
- Give us your wage statements
- Show your driver's license
- Use your debit or credit card

We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.

**Why can't I limit all sharing?**

Federal law gives you the right to limit only

- Sharing for affiliates' everyday business purposes - information about your credit worthiness
- Affiliates from using your information to market to you
- Sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing.

**What happens when I limit sharing for an account I hold jointly with someone else?**

Your choices will apply to everyone on your account.

**Definitions**

**Affiliates**

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- *Our affiliates include: Companies with a Dorschel Entities name and/or MINI of Rochester, Maserati of Rochester, Alfa Romeo of Rochester and Clearwater Credit Company.*

**Nonaffiliates**

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- *Non-affiliates we share with can include: finance companies and insurance companies.*

**Joint Marketing**

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- *Our joint marketing partners include: finance companies and insurance companies.*
