Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?	<p>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</p> <ul style="list-style-type: none"> ▪ Social Security number and income ▪ Account balances and payment history ▪ Credit history and credit scores

How?	All financial companies need to share customers’ personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers’ personal information; the reasons Dealership chooses to share; and whether you can limit this sharing.

When you are <i>no longer</i> our customer, we continue to share your information as described in this notice. However, you can contact us at any time to limit our sharing.</p>

Who is providing this notice?	Dealership, as noted above.
What we do	
How does Dealership protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does Dealership collect my personal information?	<p>We collect your personal information, for example, when you:</p> <ul style="list-style-type: none"> ▪ complete an application with us ▪ open an account ▪ apply for a loan, in our dealership or on our website ▪ give us your driver’s license information <p>We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.</p>
Why can’t I limit all sharing?	<p>Federal law gives you the right to limit only</p> <ul style="list-style-type: none"> ▪ sharing for affiliates’ everyday business purposes – information about your creditworthiness ▪ affiliates from using your information to market to you ▪ sharing with nonaffiliates to market to you <p>State laws and individual companies may give you additional rights to limit sharing.</p>
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account – unless you tell us otherwise.
Definitions	
Affiliates	<p>Companies related by common ownership or control. They can be financial and nonfinancial companies.</p> <p>Our affiliates include those dealerships within the Performance Automotive Network including: Performance Toyota, Performance Honda, Performance Lexus, Performance Kings Honda, Performance Lexus RiverCenter, Performance Chrysler Jeep Dodge RAM Centerville, Honda Marysville, Honda Marysville Motorsports, Toyota Direct, Performance Chrysler Jeep Dodge RAM, Performance Chrysler Jeep Dodge RAM Delaware, Toyota Bountiful, Performance Honda Bountiful, Performance Ford Lincoln Bountiful, Performance Ford Tooele, Performance Chrysler Jeep Dodge RAM Tooele, and Performance Chevrolet Buick Tooele.</p>
Nonaffiliates	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <p>Except as required by American Honda Motor Co., Inc. (“Honda Corporate”), Dealership does not share personal information with nonaffiliates for marketing purposes. Personal information generated by Dealer website forms will be used and tracked by Honda Corporate. Your personal information will be shared with Honda Corporate and may be used by Honda Corporate for their own marketing purposes. Dealership and Honda Corporate are nonaffiliated third parties and this website’s privacy statement does not apply to Honda Corporate Website.</p>
Joint Marketing	<p>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</p> <p>Dealership does not jointly market.</p>
