Ilderton 90th Anniversary Celebration Event OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. PURCHASE DOES NOT IMPROVE CHANCES OF WINNING. THE FOLLOWING CONTEST IS OPEN TO LEGAL RESIDENTS OF U.S. ONLY, AND WHO MEET THE ELIGIBILITY REQUIREMENTS (AS DEFINED IN THE RULES BELOW). VOID ELSEWHERE AND WHEREVER PROHIBITED. EVENT NAME: "Ilderton 90th Anniversary Celebration" (the "Event").

Event is governed by these official rules ("Official Rules"). By participating, each entrant agrees to the Official Rules.

EVENT REGISTRATION DATES: Event registration will begin at 10 a.m. Eastern Standard Time (EST) on July 15, 2016 and will end at 6 pm (EST) on September 30, 2016 (the "Registration Period"). Event is subject to all applicable federal, state and local laws and regulations.

<u>ELIGIBILITY – WHO MAY ENTER</u>: Event is open to legal residents of the U.S., who are aged 18 or older as of date of entry and have a valid driver's license, except the following classes of persons who are not eligible to enter:

"Immediate family members" includes, for purposes of this promotion, parents (including in-laws), grandparents, siblings (including step-siblings), children (including step-children), grandchildren (including step grandchildren) and each of their respective spouses.
- b. Individuals who are unable or unwilling to visit the dealership during the registration period to enter.

HOW TO ENTER: During the Registration Period, participants may visit Ilderton Dodge Chrysler Jeep Ram located at 701 S. Main Street in High Point, North Carolina during normal business hours to obtain an official entry form. Fully complete an official entry form with all required information including name, address, phone and email and deposit completed entry into the official registration box provided at the dealership. Official entry forms are available while supplies last. NO PURCHASE NECESSARY to obtain or submit an official entry form. All entries must be fully complete and legible, and received by September 30, 2016 at 6 pm EST. Entries must be handwritten and cannot be photocopied, printed by machine, computer printed or otherwise mechanically reproduced. Sponsor is not responsible for lost, late, delayed, damaged, stolen, illegible, incomplete, mutilated or misdirected entries, all of which shall be void. Entries become property of Sponsor and will not be returned.

Maximum of one (1) entry per person, per day. By entering Event, you affirm that you have read and accept these Official Rules. The laws of the United States and State of North Carolina apply to and govern this Event.

FINALIST SELECTION AND NOTIFICATION: On October 1, 2016, ninety (90) names will be randomly selected from the valid entries received. The 90 names selected shall be deemed Finalists. There is a maximum of one Finalist per household. Each selected Finalist will be notified initially by phone or in person of their selection. During the Finalist notification phone call, the Finalist must confirm his/her eligibility, and indicate their willingness and ability to attend and participate in the grand prize reverse raffle event that will take place on October 15, 2016 ("Grand Prize Event")

Any selected Finalist who does not meet the eligibility requirements, who does not wish to participate in the Ilderton 90th Anniversary celebration grand prize event, or who is unable or unwilling to attend the Grand Prize Event will be disqualified. No alternate Finalists will be selected. Only Finalists selected and notified by sponsor will be eligible to participate in the Grand Prize Event. All other entrants are ineligible. Finalists will be notified of any changes at the time of their selection and/or notification.

<u>WINNER SELECTION</u>: Maximum of one (1) grand prize award: After the Finalist check-in period has ended, a random reverse raffle drawing shall be conducted by the Sponsor from among all eligible Finalists who have checked-in and are present at the Grand Prize event to select a total of one (1) potential grand prize winner. The <u>last</u> name drawn shall be the grand prize winner. (See grand prize description below).

Odds of being selected as the potential grand prize winner are dependent upon the total number of eligible entries received in the Event and also the number of Finalists who are present at the Grand Prize Event. Decisions of the Administrator in the selection and determination of grand prize winner and all matters relating to this Event are final and binding in all respects.

If the selected Finalist does not meet the eligibility requirements, or elects to decline the prize, he/she will be disqualified and, the second to last name drawn in the reverse raffle from among the eligible Finalists shall be declared the grand prize winner. Winner must pay \$1926 plus tax, tag and \$529 dealer administrative fee and accept delivery of Vehicle from Sponsor. Sponsor will solely designate and specify available vehicle including make, model, color and options. Grand Prize winner may not substitute, exchange, or apply the vehicle's value towards a higher cost or alternate vehicle. Sponsor reserves the right to award an alternate vehicle of equal or greater value should the Vehicle not be available.

Grand Prize winner is responsible for paying \$1926 plus 3% highway use tax, vehicle title and registration fees and \$529 dealer administrative fee. Grand Prize winner shall also be solely responsible for paying for and maintaining insurance on the Vehicle and paying all other applicable taxes, including property tax on the Vehicle and income taxes.

Released Parties shall not be responsible for mechanical, technical, printing,

typographical, human, or other errors or problems relating to or in connection with the Event, including, without limitation, errors or problems which may occur in connection with the administration of the Event, the processing of entries, the announcement of the prize or in any Event-related materials. If for any reason this Event (or any portion thereof) is not capable of running as planned due to tampering, unauthorized intervention, fraud, or any other causes which corrupt or affect the administration, security, fairness, integrity, or proper conduct of the Event (or any portion thereof), Sponsor reserves the right, at its sole discretion, to cancel, terminate, modify or suspend the Event (or any portion thereof). If terminated, Sponsor reserves the right, at its discretion, to select the potential winner from among all non-suspect eligible entries received up to time of such action. Sponsor also reserves the right to disqualify any individual who tampers with the entry process, who disrupts the administration or proper play of this Event, intends to annoy, abuse, threaten or harass any other entrant or Sponsor or Event representative or who is otherwise in violation of these Official Rules and void all associated entries. Released Parties shall not be liable to winner or any other person for failure to supply the prize or any part thereof by reason of any acts of God, any actions, regulations, orders, or requests by any governmental entity, equipment failure, terrorist acts, war, fire, unusually severe weather, embargo, labor dispute or strike, labor or material shortage, transportation interruption of any kind, or any other cause.

IN CASE OF DISPUTES: By participating, each participant agrees that (1) any and all disputes, claims, and causes of action arising out of or in connection with this Event, or any prizes awarded, shall be resolved individually, without resort to any form of class action. Any legal proceeding shall take place only in the District or Superior Court of Guilford County, North Carolina; (2) any and all claims, judgments, and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Event, and in no event will participant be entitled to receive attorneys' fees or other legal costs; and (3) under no circumstances will participant be permitted to obtain awards for, and participant hereby waives all rights to claim, punitive, incidental, and consequential damages, and any other damages, other than for actual out-of-pocket expenses, and any and all rights to have damages multiplied or otherwise increased.

All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of participant and Sponsor in connection with this Event, shall be governed by, and construed in accordance with the laws of the State of North Carolina, without giving effect to any choice of law or conflict of law rules or provisions (whether of the State of North Carolina or any other jurisdiction), that would result in the application of the laws of any jurisdiction other than the State of North Carolina to the dispute.
