WHY?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all the sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.		
WHAT?	The types of personal information we collect and share depend on the product or service you have with us. This information can include: <div>Social Security number and income - Account Balances and Payment History - Credit History and Credit Scores</div>		
HOW?	When you are <i>no longer</i> our customer, we continue to share your information as described in this notice All financial companies need to share customers' personal inforation to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Infiniti of Denver chooses to share and whether you can limit this sharing.

What we do	
How does Infiniti of Denver protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does Infiniti of Denver collect my personal information?	We collect your personal information, for example, when you: Apply for financing or provide employment information - Show us your driver's license or give us income information - Give us your employment history. We also collect your personal information from others, such as credit bureaus, affiliates or other companies.
Why can't I limit all sharing?	Federal law gives you the right to limit only: <i>Sharing for affiliates' everyday business purposes, information about your creditworthiness - affiliates from using your information to market to you - Sharing for nonaffiliates to market to you.</i> State laws and individual companies may give you additional rights to limit sharing.
Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies. <i>Affiliates may include other dealerships and product or service providers</i>
Nonaffiliates	Companies not related by common ownership or control. They can be financial or nonfinancial companies. WE DO NOT SHARE with nonaffiliates so they can market to you
Joint Marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. Joint marketers may include nonaffiliated financial companies such as other dealerships and lenders.
