### TIRE & WHEEL PROTECTION WITH OPTIONAL COSMETIC COVERAGE

#### REPAIRS OR REPLACES TIRES AND WHEELS

- Replaces covered tires and wheels that are structurally damaged<sup>1,2</sup>
- Towing reimbursement up to \$100<sup>3</sup>
- Optional cosmetic coverage for wheels available<sup>4</sup>
- No limit to the number of structural damage claims
- No mileage limitations

EXCLUSIONS APPLY:<sup>5</sup> Damage to tires with less than 3/32" tread depth at the lowest point on the tire at the time of damage. Cosmetic damage to tires, if Optional Cosmetic Coverage is not purchased. Cosmetic damage to chrome or chrome-clad wheels, even if Optional Cosmetic Coverage is purchased. Damage caused by vandalism. Repairs or replacements made without prior authorization. Damage caused by road conditions found in construction zones or sites. Failures from normal wear and use, improper wear, or dry rot.



### DENT PROTECTION

#### REMOVES MINOR DOOR DENTS AND DINGS

- The paintless dent repair process removes minor dents without harming your vehicle's factory paint job and finish
- Repairs can be performed conveniently at your home, office, or your Land Rover retailer
- Hail damage covered up to the lesser of your primary insurance deductible (if a claim was filed) or \$1,000 per incident<sup>6</sup>
- Unlimited claims, no mileage limitations, and no deductible

EXCLUSIONS APPLY:<sup>5</sup> Dents or dings that are larger than four (4) inches in diameter. Dents or dings that cannot be repaired by the paintless dent repair process. Damage caused by vandalism. Repairs that will affect or damage the vehicle's paint or finish.



### WINDSHIELD PROTECTION

#### REPAIRS WINDSHIELD DUE TO CHIPS AND CRACKS<sup>7</sup>

- Repairs chips and cracks in the front windshield caused by propelled rocks or other road hazard debris
- Provides unlimited repairs and one (1) replacement of the front windshield during the coverage period<sup>5</sup>
- Repairs can be performed conveniently at your home, office, or your Land Rover retailer
- Unlimited claims, no mileage limitations, and no deductible

EXCLUSIONS APPLY:<sup>5</sup> Damage to areas other than the front windshield. Stress cracks or cracks over six (6) inches. Damage caused by hail, vandalism, or neglect. Replacement of the front windshield.



### KEY PROTECTION

#### REPLACES VEHICLE KEY OR REMOTE

- Replaces the covered vehicle key or remote if lost or damaged, up to \$800 per occurrence
- 24-hour vehicle lockout assistance, up to \$100 per occurrence
- Towing reimbursement, up to \$100 per occurrence
- Taxi, rental vehicle, or public transportation reimbursement, up to \$75 per occurrence
- Additional benefits<sup>8</sup>, including home lockout assistance, replacement of non-programmable keys on the key ring, and emergency message relay

EXCLUSIONS APPLY:<sup>5</sup> Replacement keys, if you did not receive two (2) master keys at the time of purchase or lease of the vehicle. Replacement of keys covered by a manufacturer, repairer, or supplier's warranty or recall. Any replacement keys made without prior authorization.

Cosmetic wheel repair is limited to a total of eight (8) individual wheel repairs during the Agreement term. <sup>5</sup> Additional exclusions may apply.
