

Mercedes-Benz USA, LLC Terms and Conditions for the Model Year 2025 Charging Offer:

Offer Information: Customers who purchase a Model Year 2025 battery electric vehicle (BEV) (hereinafter “MY25 BEV”), excluding eSprinter, are eligible to receive one of the following:

- Option 1: Mercedes-Benz Home Wallbox (MSRP \$945), excluding installation costs which are the responsibility of the customer **OR**
- Option 2: \$1,000 charging voucher on the customer’s MB.CHARGE Public account which is valid at all CPOs in the MB.CHARGE Public network except Tesla Supercharger network. Tesla Supercharger session must always be paid by the customer directly and cannot be debited from the charging voucher. The voucher is valid for two years from activation date*. The voucher is only applied to charging sessions which are initiated using the MB.CHARGE Public service (ex. using MBUX, Mercedes-Benz app, RFID card or Plug & Charge). Any charging sessions initiated outside of MB.CHARGE Public (ex. using the CPO’s own application or the customer’s credit card to start a charging session) will not have the voucher applied and the cost will be borne by the customer. Mercedes-Benz USA will not refund the customer for any charging sessions which were not correctly initiated in order to utilize the voucher.

Eligibility Information: All retail customer sales channels are eligible to receive the offer for each new MY25 all-electric passenger car purchased, excluding eSprinter, rental and fleet customers. Activation of Mercedes-Benz Digital Extras and MB.CHARGE Public service are required to receive the charging voucher. The customer must make a selection at the point of delivery using the dealer delivery app and may not revise their selection or make a selection outside of the delivery process.

Offer Processing:

- Option 1: To receive the Mercedes-Benz Home Wallbox, customers must complete all required actions after making their selection to fulfill their order. An email will be automatically generated and sent to customer’s recorded email address with details to finalize the order. The customer must order the wallbox by submitting an online order with MBUSA’s vendor. It is not automatically sent to the customer after making the selection.
- Option 2: Upon successful activation of MB.CHARGE Public account* and acceptance of offer at time of delivery, \$1,000 charging voucher will be automatically applied to customer’s MB.CHARGE Public account. Customers can check the balance of the voucher through the Mercedes-Benz app or in the ChargePoint driver portal.

*The charging voucher is subject to the program terms of Mercedes-Benz USA’s service provider ChargePoint, which are presented to the customer when the MB.CHARGE Public service is activated. All MY25 BEV customers, excluding eSprinter, also receive two years of free unlimited charging at Mercedes-Benz High Power Charging (“MB HPC”) network; those charging sessions are always free during such two-year period and are therefore not covered by the \$1,000 charging voucher if selected. However, idle fees incurred at MB HPC stations are the responsibility of the customer and will be charged to the customer’s MB.CHARGE Public account, which could be covered by either a valid payment method associated with the account or the balance of the charging voucher.

Other Terms: The offer is non-refundable, non-transferrable, and non-cancelable once a selection has been made and has no cash value. Additionally, the offer is subject to change and may be discontinued at any time. In the event of a retail cancelation or buyback, if 1) the original customer who redeemed the charging offer is no longer the owner of that vehicle, or 2) the eligible Mercedes-Benz electric vehicle is subsequently disconnected from the customer’s MB.CHARGE Public account, then MBUSA has the right to revoke the charging voucher or reclaim the Mercedes-Benz Wallbox from the customer depending on whichever charging offer the customer originally selected.
