## Why?

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. ## What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and income
- Account Balances and payment history
- Credit scores and credit history

When you are no longer our customer, we continue to share your information as described in this notice.

## How?

## What we do

How does **Midstate Auto Group of Vermont LLC** protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

How does **Midstate Auto Group of Vermont LLC** collect my personal information?

We collect your personal information, for example, when you

- Apply for financing or Give us your income information
- Show your driver's license or Provide employment information
- Give us your employment history

We also collect your information from others, such as credit bureaus, other companies, or when verifying information you provided to us.

Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes—information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing.

## Definitions

Affiliates

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- *Midstate Auto Group of Vermont LLC consists of the following related companies d/b/a Midstate Dodge, Midstate Hyundai or Upper Valley Auto Mart.*

Nonaffiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- *Midstate Auto Group of Vermont LLC does not share with non-affiliates so they can market to you.*

Joint marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- *Midstate Auto Group of Vermont LLC does not jointly market.*
