



### COVERAGE EXCLUSIONS MAY APPLY:<sup>5</sup>

Damage to tires with less than 3/32" tread depth at the lowest point on the tire at the time of damage. Cosmetic damage to tires if Optional Cosmetic Coverage is not purchased. Cosmetic damage to chrome or chrome-clad wheels, even if Optional Cosmetic Coverage is purchased. Damage caused by vandalism. Repairs or replacements made without prior authorization. Damage caused by road conditions (such as uneven lanes or metal plates) found in construction zones or construction sites. Failures from normal wear and use, improper wear, or dry rot.

<sup>1</sup> Repair of the structurally damaged tire or wheel will be attempted first. If the structurally damaged tire or wheel cannot be repaired, it will be replaced. There is a deductible for structural damage replacement claims. Please see your Agreement for details. <sup>2</sup> Structural damage prevents wheel from sealing to tire or maintaining the tire manufacturer's air pressure specifications. <sup>3</sup> There is no deductible associated with the repair of cosmetic damage to wheels. Cosmetic wheel repairs are limited to sanding, painting, or refinishing the wheel. Cosmetic wheel repair is limited to a total of eight (8) individual wheel repairs during the Agreement term. <sup>4</sup> Towing reimbursement is eligible up to \$100 per incident in the event of covered road hazard damage. <sup>5</sup> Additional exclusions may apply. Please see your Agreement for specific coverage details, including limitations or exclusions.
