- An approved facility or shop must be used. Your shop may qualify.

Eligibility

- Current model year plus two model years old and under 35,000 mile at time of sale.
- January 1st of each year constitutes the model year change.
- Ford, Mercedes Sprinter, General Motors and Dodge Ram vehicles only (Gas & Diesel Engines).

- Fleet Elite provides Exclusionary Coverage for **Commercial Vehicles** – allows coverage for all mechanical or electrical parts except those listed under Section V “What Is Not Covered” of the contract agreement.
- Full Seals & Gaskets Coverage included.
- No Wear & Tear exclusion on any Fleet Elite Plan.
- Coverage allows for Multiple Drivers.
- No Limit on the Amount of Hours of Engine Operation on any Fleet Elite Plan.
- Only Surcharge on Fleet Elite is Modified A/C to cover Auxiliary or Add-On Air Conditioning Units (Internal Components).
- \$100 Standard Deductible per Repair Visit.
- Repairs may be made by any licensed repair facility in the United States or Canada.
- Limits of Liability:
 - Per Repair Visit
 - Our liability for any one repair visit shall not exceed the Actual Cash Value of the vehicle at the time of the repair visit.
 - Aggregate
 - The total benefits paid while the contract is in force shall not exceed the retail price paid for the vehicle.
- All claims require prior authorization. Emergency repair claim service available after normal business hours.
- Coverage Terms Available:
 - 48 Months / 100,000 or 120,000 Miles
 - 48 Months / 75,000 Miles
 - 60 Months / 100,000 or 120,000 Miles
- Underwriting Guidelines:
 - Vehicles must be current +2 years old and have less than 35,000 miles at time of sale (January 1st of each year constitutes the model year change).
 - Coverage starts on contract purchase date and at zero (0) miles and will expire according to the time/mileage of the plan selected (whichever comes first).
 - Coverage for Ford, General Motors and Dodge Ram vehicles.
 - Coverage for both Gas & Diesel engines.
- Ineligible Vehicle:
 - ANY MAKE OR MODEL NOT SPECIFICALLY LISTED IN THE COST GUIDE, VEHICLES OVER 550/5500 RATING, VEHICLES THAT DO NOT HAVE A VALID MANUFACTURER’S VIN, ALL GREY MARKET VEHICLES, ANY VEHICLE WITH A BRANDED OR SALVAGE TITLE, ANY IN EXCESS OF TWO (2) MODEL YEARS AND ANY VEHICLE IN EXCESS OF 35,000 MILES; VEHICLES USED IN RENTAL, TAXI SERVICES, ROAD REPAIR OPERATIONS, CONSTRUCTION, JOB SITE ACTIVITIES, PRINCIPALLY OFF-ROAD USE, RACING OR COMPETITIVE DRIVING, OR SNOW PLOW REMOVAL.
