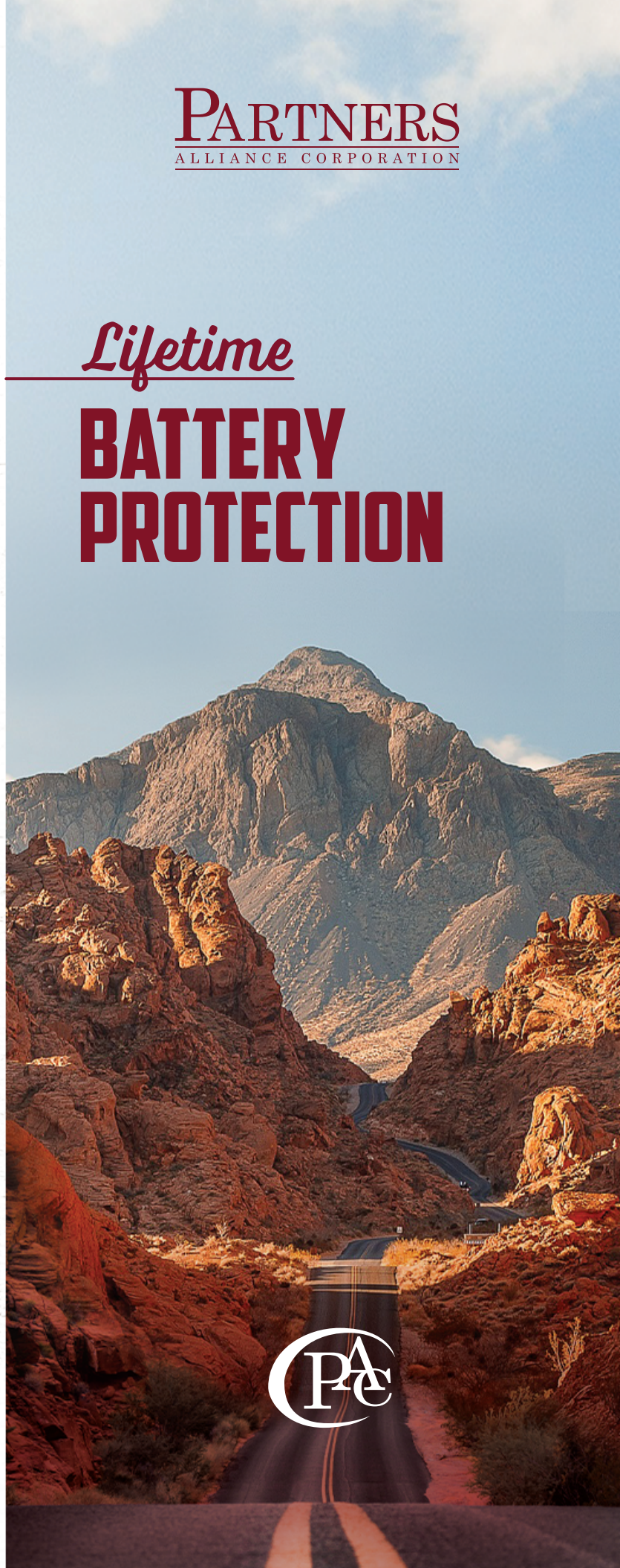

Why do batteries die?

TIME



With enough time, everything deteriorates. The same is true for batteries. After about 3-5 years, the parts inside of your battery will start to degrade.

LONG PERIODS of INACTIVITY

If your car sits for anywhere from about 6 wks to 6 mths without being driven, your battery may need to be recharged.

FAILED ALTERNATORS

If your alternator is going bad, it may not produce enough power to recharge your battery at the rate it is being discharged; resulting in your battery discharging completely.

TERMS for VEHICLES

NEW

For new vehicles, the term of this limited warranty begins on the sale date and continues for the LIFETIME of the vehicle as long as you own the covered vehicle.

USED

For used vehicles, the coverage under this limited warranty begins after a 90-day waiting period and continues for the LIFETIME of the vehicle as long as you own the covered vehicle.
