THE ODDS OF BEING SELECTED DEPEND ON THE NUMBER OF ELIGIBLE ENTRIES RECEIVED DURING THE PROMOTION PERIOD.

 - 2. **SPONSOR**: The Promotion is conducted by Charleston Automotive Company, a South Carolina general partnership (1518 Savannah Hwy, Charleston, SC 29407) ("*Sponsor*").
- 3. **OFFICIAL RULES**: Participation in the Promotion constitutes entrant's full and unconditional agreement to and acceptance of these Official Rules and the decisions of the Sponsor, which are final and binding. Winning a Prize is contingent upon fulfilling all requirements set forth herein. A copy of these Official Rules, or the name of the Prize winners, may be obtained by sending a written request to Sponsor's address listed in **Paragraph 2** above.
- 4. **ENTRY PERIOD & ENTRY**: The Promotion begins on (i) March 1, 2018, at 11:00 a.m. E.T. and ends on March 18, 2018, at 3 p.m. E.T. (the "*Promotion Period*"). To enter, test drive a new motor vehicle offered for sale by Sponsor by visiting Sponsor's at the address in **Paragraph 2** above prior to expiration of the Promotion Period. **ENTRIES SUBMITTED BEFORE OR AFTER THE PROMOTION PERIOD WILL BE DISQUALIFIED**. Limit one entry per household. To enter without test driving a vehicle, legibly write your name, address, telephone number and email address and submit it to Sponsor at Sponsor's address listed in **Paragraph 2** above prior to expiration of the Promotion Period. All entries become the exclusive property of Sponsor and will not be acknowledged or returned. Sponsor's clock is the official clock for all purposes of this Promotion.
- 5. **DRAWINGS**: On March 19, 2018, a Sponsor-designated representative will randomly select the name of two potential winner of the Prize in a random drawing of all eligible and proper entries received during the Promotional Period. The odds of being selected depend on the number of eligible entries received during the Promotion Period. The odds of an entry winning any Prize will be the same, whether the entry was standard or submitted by the alternate means of entry. Entrants need not be present to enter and to win the Prize. The Prize will be awarded only on verification by Sponsor that all Promotion requirements have been met by the winner and upon winner signing such acknowledgement as Sponsor may require.

If the operation, security, or administration of the Promotion is impaired in any way for any reason, including, but not limited to fraud, virus, or other technical problem, the Sponsor may, in its sole discretion, either: (a) suspend or terminate the Promotion to address the impairment and then resume the Promotion in a manner that best conforms to the spirit of these Official Rules; or (b) award the Prizes at random from among the eligible entries received up to the time of the impairment. The Sponsor reserves the right in its sole discretion to disgualify any individual it finds to be tampering with the entry process or the operation of the Promotion or to be acting in violation of the Official Rules or in an unsportsmanlike or disruptive manner or impairs the administration, security, fairness or proper entry into the Promotion.
