## Definitions

Affiliates	<ul> <li>Companies related by common ownership or control. They can be financial and nonfinancial companies.</li> <li>Our affiliates include Penske Automotive Group, Inc. and all companies that it owns.</li> </ul>
Nonaffiliates	<ul> <li>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</li> <li>We do not share with nonaffiliates so they can market to you except for joint marketing arrangements as described below.</li> </ul>
Joint marketing	<ul> <li>A formal agreement between nonaffiliated financial companies that together market financial products or services to you.</li> <li>If we have any joint marketing arrangements, our joint marketing partners may include the manufacturer affiliated lenders or other lenders.</li> </ul>
