

**FACTS****WHAT DOES THE “SCANLON IMPORTS, INC.” DEALERSHIP DO WITH YOUR PERSONAL INFORMATION?****Why?**

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

**What?**

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and Income
- account balances and payment history
- credit history and credit scores

**How?**

All financial companies need to share customers' non-public personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' non-public personal information; the reasons “Scanlon Imports, Inc.” dealerships & our affiliates choose to share; and whether you can limit this sharing.

How does the “Scanlon Imports, Inc.” dealerships protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.  The “Scanlon Imports, Inc.” dealerships maintains physical, electronic, and procedural safeguards to protect the confidentiality and security of the information we collect.
How does the “Scanlon Imports, Inc.” dealerships collect my personal information?	We collect your personal information, for example, when you <ul style="list-style-type: none"> <li>■ Apply for financing or use your credit or debit card</li> <li>■ Provide employment information or apply for a lease</li> <li>■ Give us your income information</li> </ul> We also collect your personal information from others, such as credit bureaus, affiliates or other companies.
Why can't I limit all sharing?	Federal law gives you the right to limit only <ul style="list-style-type: none"> <li>■ sharing for affiliates' everyday business purposes—information about your creditworthiness</li> <li>■ affiliates from using your information to market to you</li> <li>■ sharing for nonaffiliates to market to you</li> </ul> We also collect your personal information from others, such as credit bureaus, affiliates or other companies. State laws and individual companies may give you additional rights to limit sharing.
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account.

DEFINITIONS	
<b>Affiliates</b>	Companies related by common ownership or control. They can be financial and nonfinancial companies.  ■ <i>Scanlon Lexus, Scanlon Imports, Inc., Scanlon Acura, Scanlon Used Car Center are affiliates of one another</i>
<b>Nonaffiliates</b>	Companies not related by common ownership or control. They can be financial and nonfinancial companies.  ■ <i>Financial Institutions / Manufacturers &amp; Suppliers / Insurance Providers / Service Contract Providers</i>
<b>Joint Marketing</b>	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.  ■ Scanlon Imports, Inc. does not participate in Joint Marketing efforts
