PRIVACY POLICY

WHAT TED BRITT FORD SALES, INC. DOES WITH YOUR PERSONAL INFORMATION

Companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share and protect your personal information. Please read this notice carefully to understand what we do.

The types of personal information we collect and share depend on the product or service you have with us.

This information can include:

- Social Security number and income
- Payment history and purchase history
- Credit history and assets.

All automobile dealers need to share customers' personal information to run their everyday business-to process transactions, maintain customer accounts and report to credit bureaus. In the section below, we list the reasons companies can share their customers' personal information, the reasons Ted Britt Ford Sales, Inc. chooses to share; and whether you can limit this sharing.

How does Ted Britt Ford Sales, Inc. protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does Ted Britt Ford Sales, Inc. collect my personal information?	We collect your personal information, for example, when you: <ul style="list-style-type: none"> ▪ Apply for financing or apply for a lease. ▪ Purchase and/or finance a vehicle. ▪ Obtain service for a vehicle. ▪ Purchase parts and/or accessories. ▪ Give us your contact information. We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.
Why can't I limit all sharing?	Federal law gives you the right to limit only: <ul style="list-style-type: none"> ▪ Sharing for affiliates' everyday business purposes-information about your creditworthiness. ▪ Affiliates from using your information to market to you. ▪ Sharing for non-affiliates to market to you. ▪ State laws and individual companies may give you additional rights to limit sharing.

Definitions

Affiliates	Companies related by common ownership or control. They can be financial and non-financial companies.
Non-affiliates	Companies not related by common ownership or control. They can be financial and non-financial companies.
Joint Marketing	A formal agreement between non-affiliated companies that together market products or services to you.
