The Entrant or the parent or guardian, as applicable, shall be responsible for providing a Certificate of Insurance to the Dealership which evidences that the Vehicle is covered by a Motor Vehicle Liability Policy of Insurance issued by an insurance carrier duly authorized to transact business in the State of South Carolina which meets the requirements of SC Code Ann. Sec. 56-9-20(5), as amended, and the ancillary sections referenced therein.

**DISCLAIMER AND OFFICIAL RULES**

(a) Dealership shall have the right to rely solely on the records furnished by the Anderson County School District regarding the 2009-2010 attendance record of Entrant.

(b) No fee or other consideration has been paid by or on behalf of Entrant as a condition of entry of his or her name in the drawing.

(c) The Dealership shall have the sole right to designate the manner in which the drawing is held.

(d) The winner or, as applicable, the parent or guardian of the winner, shall sign all documents reasonably necessary to perfect transfer of title of the Vehicle from the Dealership and the payment of any applicable taxes attributable to the Vehicle.

Vehicle will be released only upon presentation by winner of satisfactory proof of insurance and a valid driver's license.
