- **AUTHORIZATION TO REPAIR:** I HEREBY AUTHORIZE THE REPAIR WORK TO BE PERFORMED ALONG WITH THE NECESSARY MATERIAL AND AGREE THAT YOU ARE NOT RESPONSIBLE FOR LOSS OR DAMAGE TO THE VEHICLE, ARTICLES LEFT IN VEHICLE, FIRE, THEFT, OR ANY OTHER CAUSE BEYOND YOUR CONTROL OR FOR DELAYS CAUSED BY UNAVAILABLE PARTS OR DELAYS IN PARTS SHIPPED BY SUPPLIER OR TRANSPORTER. I HEREBY GRANT YOU AND/OR YOUR EMPLOYEES' PERMISSION TO OPERATE THE VEHICLE HEREIN DESCRIBED ON STREETS OR HIGHWAYS FOR INSPECTION. AN EXPRESSED MECHANIC'S LIEN IS HEREBY ACKNOWLEDGED ON ABOVE VEHICLE TO SECURE THE AMOUNT OF REPAIRS THERETO. CUSTOMER IS AWARE OF DAMAGE NOTED ON DIAGRAM, AND AGREES THAT IT OCCURRED PRIOR TO ACCEPTANCE TO TROPHY NISSAN ON THIS DATE.
- **ARBITRATION:** CUSTOMER AGREES THAT ANY CONTROVERSY OR CLAIM BY OR BETWEEN CUSTOMER AND TROPHY NISSAN (INCLUDING ANY OF ITS AGENTS OR REPRESENTATIVES) OF ANY KIND OR NATURE WHATSOEVER SHALL BE SETTLED BY ARBITRATION IN ACCORDANCE WITH THE RULES OF THE AMERICAN ARBITRATION ASSOCIATION OR THE NATIONAL ARBITRATION FORUM. THERE SHALL BE NO CLASS ACTION ARBITRATION OR RELIEF. THE ARBITRATION AWARD AND/OR DECISION RENDERED BY THE ARBITRATOR MAY BE ENTERED IN ANY COURT HAVING PROPER JURISDICTION. UNLESS THE ARBITRATOR DETERMINES THAT APPLICABLE LAW OR THE ENFORCEABILITY OF THIS ARBITRATION CLAUSE REQUIRES OTHERWISE, EACH PARTY SHALL BEAR ITS OWN COSTS AND EXPENSES (INCLUDING ATTORNEY'S FEES AND EXPENSES) IN CONNECTION WITH ANY OTHER ARBITRATION PROCEEDING. BOTH CUSTOMER AND TROPHY NISSAN RETAIN THE RIGHT TO EXERCISE SELF-HELP REMEDIES, FILING OR ANSWERING SUIT, OR SEEKING OR OBTAINING PROVISIONAL REMEDIES FROM THE COURT. IF ANY PART OF THIS ARBITRATION CLAUSE IS DEEMED OR FOUND UNENFORCEABLE FOR ANY REASON THE REST OF THE ARBITRATION CLAUSE REMAINS ENFORCEABLE.
