In addition it is necessary to obtain and read a copy of HM Customs & Excise Notice 728. This is supplied with VAT 411 form.

VAT 410 Vehicles destined for non-EC countries

In addition it is necessary to obtain and read a copy of HM Customs & Excise Notice 705. This is supplied with VAT410 form.

Visiting military personnel stationed in UK must obtain form 941 from their military base. The Delivery Centre must receive this form at least 14 days prior to delivery, plus Original Insurance Cover note stamped by Customs & Excise.

Diplomats who are stationed in the UK must make the application for customs clearance through their embassies. C428 form, stamped by protocol & embassy, plus Original Insurance Cover note.

Military or Diplomatic personnel who wish to purchase a vehicle other than UK specification, and intend to keep the vehicle in the UK for more than 12 months, will have to personally have collect the vehicle at either the factory or another European delivery point. British temporary resident plates are valid for a maximum of 364 days.

#### INSURANCE

**Since the British Customs Authorities can be very discriminating, it is mandatory to contact the Delivery Centre at least 14 days prior to delivery.**
