- All maintenance and wear item replacements are made with Ford approved parts.
- LMPP includes coverage for 8 wear items, as required, due to failure caused by normal wear or defect.

## SCHEDULED MAINTENANCE AND WEAR ITEMS

LMPP covers all required scheduled maintenance items, as recommended in your Customer Information Guide or Owner's Guide. It also includes coverage for 8 wear items, as required, due to failure caused by normal wear or defect:

- Brake pads and linings
- · Brake rotors
- Clutch disc
- Engine belts and hoses
- Light bulbs (excluding headlamps)
- Shock absorbers
- Spark plugs
- Wiper blades

## NO DEDUCTIBLE

The LMPP Plan comes with a \$0 deductible.

# OPTIONAL RENTAL VEHICLE REIMBURSEMENT

If purchased, includes first-day coverage up to \$35/day for up to 2 days for maintenance and repairs covered by the Basic Coverage under the New Vehicle Limited Warranty or Ford ESP. This benefit will also be available for Ford Recalls or Customer Satisfaction Programs involving an ESP-covered component for Lincoln vehicles. Never be without a vehicle — even when your vehicle is getting an oil change!

## BACKED BY FORD

Most importantly, LMPP is backed by Ford Motor Company of Canada, Limited, and is specifically designed to meet maintenance requirements for Lincoln vehicles. LMPP is honoured at authorized Lincoln Dealers only in Canada and Ford, Lincoln and Mercury Dealers in the United States.

# LINCOLN MAINTENANCE PROTECTION PLAN (LMPP) COVERAGE FOR SCHEDULED MAINTENANCE

LMPP covers all required scheduled maintenance as outlined in your Customer Information Guide or Owner's Guide.† The following services are representative of recommended maintenance for your vehicle. Your actual plan will be based on your Lincoln vehicle's maintenance needs as indicated in your Customer Information Guide or Owner's Guide:

- · Change engine oil and replace oil filter
- Inspect tires for wear, rotate and measure tread depth
- Inspect wheel and related components for abnormal noise, wear, looseness or drag
- Perform multi-point inspection:
  - Check and top-up fluid levels: brake, coolant recovery reservoir, manual and automatic transmission (if equipped with an underhood dipstick), power steering (if equipped) and window washer
  - Inspect tires for wear and check air pressure, including spare
  - Check exhaust system for leaks, damage, loose parts and foreign material
  - Check battery performance
  - Check operation of horn, exterior lamps, turn signals and hazard warning lights
  - Check radiator, coolers, heater and air conditioning hoses
  - Inspect windshield washer spray and wiper operation
  - Check windshield for cracks, chips and pitting
  - Inspect for oil and fluid leaks
  - Inspect engine air filter
  - Inspect half-shaft dust boots, if equipped
  - Check shocks and struts, and other suspension components for leaks and damage
  - Inspect steering and linkage
  - Inspect accessory drive belt(s)
  - Inspect clutch operation, if equipped
- Inspect automatic transmission fluid level (if equipped with a dipstick); consult Dealer for requirements
- Inspect brake pads, shoes, rotors, drums, brake linings, hoses and parking brake
- Inspect engine cooling system for strength and hoses
- Inspect exhaust system and heat shields
- · Inspect half-shaft dust boots, if equipped
- Inspect and lubricate steering linkage, ball joints, suspension, tie-rod ends, driveshaft and U-joints
- Inspect cabin air filter, if equipped
- Replace cabin air filter, if equipped



# SELECT THE COVERAGE THAT IS RIGHT FOR YOU

The LMPP Plan is available up to the time and distance intervals as listed below. Coverage begins at the time of plan purchase and expires upon reaching your selected time or distance travelled limitation, whichever occurs first.\* The number of service visits listed for each of the plans is the maximum number of visits covered.§ Should the maximum number of service visits be reached prior to the expiration of the selected plan, the 8 wear items will still be covered during the selected plan coverage period. While maintenance services can be completed at any time during the plan coverage, Ford Motor Company of Canada, Limited recommends that the scheduled maintenance, as outlined in your vehicle's applicable

- You can choose a coverage plan that meets your driving needs and habits – plans are available in 6 months/8,000 kilometres, 6 months/12,000 kilometres, or 12 months/16,000 kilometres maintenance intervals. Wear items and failures of covered components, due to normal wear or defect, are included for the time and distance you select.§§
- Coverage begins at the time of plan purchase and expires upon reaching your selected time or distance travelled limitation, whichever occurs first.\* You can only purchase LMPP for your vehicle before the earlier of 12 months or 20,000 kilometres from the warranty start date.
- The Lincoln Maintenance Protection Plan and Extended Service Plan prices and component coverage are subject to the pricing and component coverage in effect at the time the plan is purchased.
   Plans and prices are subject to change without notice. See your participating Dealer for details. LMPP/ESP are subject to GST, PST and HST where applicable.

This benefit will also be offered for Recalls or Customer Satisfaction Programs involving an ESP-covered component for Ford, Lincoln or Mercury vehicles only. A first-day rental option is available on Ford FSP New Vehicle Plans.
